This agreement is between Henry Trimble Animal Control and the above-named foster parent. Henry Trimble Animal Control agrees to give the foster parent possession and control of foster animal(s) contingent upon the terms outlined below. As a foster parent, I agree to the following terms:

1. To provide food, shelter, and care for the foster animal and assume all responsibility for the animal's wellbeing.
2. To ensure that the dog lives primarily indoors and is NOT left outside unsupervised, even in a fenced yard, for extended periods. If the foster parent does not have a fenced yard, the dog will live inside at all times and be taken outside on a leash on a regular basis for exercise and elimination needs.
3. To comply with all state and local laws/ ordinances relative to the keeping and care of the animal.
4. To assume all responsibility for damage caused by the animal either directly or indirectly while in the foster parent's direct control.
5. The foster parent understands and agrees the Henry Trimble Animal Services will take every precaution necessary to ensure that the animal is in reasonably good health. However, Henry Trimble Animal Services cannot be held responsible/ liable for any unforeseen health problem that may develop once an animal is in the foster parent's care. If unforeseen problems arise, the foster parent is responsible for keeping the animal separated from any other resident pet (in cases for contagious and/or easily transmittable illnesses) and is also responsible for any medical needs of **resident pet(s)** as a result of such.
6. Understand that I am making a commitment to fostering an animal during/ while it receives the necessary vetting/ training to be deemed adoptable and that at such time Henry Trimble Animal Services finds appropriate long-term/ permanent placement for the animal.
7. Agree to bringing the animal to veterinarian services approved by Henry Trimble Animal Services for vaccinations, spay/ neuter surgery or any other medical treatments as deemed necessary. (All treatments **MUST** be pre-approved by Henry Trimble Animal Services or foster parent will be liable for payments of treatments)
8. In the event that the foster parent cannot continue to foster the animal the foster parent will contact Henry Trimble Animal Services and will await the finding of a new placement to be made for the animal (2-4 weeks).
9. Hereby agree to indemnify and hold harmless Henry Trimble Animal Services from any and all liability arising out of or in consequence of, or injury sustained as a result of, any activity connected with volunteering for Henry Trimble Animal Services as a foster home.
10. Understand and agree to be responsible for arranging for a safe care of the foster animal in the event of travel and agree to pay all related expenses.

11. To carry sufficient homeowner's/ renter's insurance to cover injury or damage caused by a foster pet and is aware of any breed restrictions that may be in place.
12. Agrees to allow Henry Trimble Animal Services onto property where the animal will be kept for an inspection and understand that Henry Trimble Animal Services holds the right to do visits to property while the animal is in the care of foster parent.

By signing this agreement, the foster parent agrees to have read and understand and agrees to abide by all of its provisions. Henry Trimble Animal Services may reclaim the animal, if in their judgment the animal is not being cared for properly, or if in Henry Trimble Animal Services's sole discretion, it is determined that the foster parent has not complied with the terms of this agreement.
